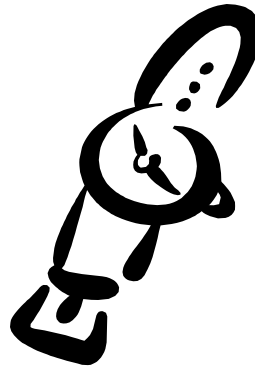

Milfoil

Everyone knows that Lake Massesecum has a serious milfoil problem and Lake Sunapee has also reported milfoil. To help prevent Lake Todd from being next, please **MAKE SURE YOUR BOAT AND MOTOR ARE THOROUGHLY CLEAN BEFORE PUTTING THEM INTO LAKE TODD.** Milfoil is a submerged aquatic plant with fine, densely packed narrow leaves whorled around a main stem. It can grow up to 10 feet and may exhibit a 3-inch green spike-like flower above the water line. A cross section of the stem reveals "pie shaped" air chambers. It reproduces and spreads primarily through fragmentation: plant fragments break off from the parent plant through wind action or boat traffic, settle in a new location, take root and establish a new plant.

Emergency Action Plan

We have received notice from the New Hampshire Department of Environmental Services that our Emergency Action Plan for the dam has never been tested. Our deadline was March 15, 2002, after which time we would be subject to a fine. I requested an extension until the end of the summer; their response was to extend the deadline only until June 30, 2002. The notification flow chart for our plan is supposed to be tested yearly, and our original plan is dated 12/15/93. Patty Dugdale and I are currently revising the flow chart and are hopeful that we will be able to comply with the testing requirements prior to June 30. The tiniest piece of this exotic weed will spread rapidly and will quickly inhabit our valuable shoreline, impairing recreational activities. If you think you see milfoil in the lake, please call one of the board members or Gerry Gold (938-2406), our Milfoil Representative on a newly formed committee that includes Lake Massesecum and Lake Sunapee. Call immediately, even if you are not sure what the plant is; it's always better to play it safe! If it can be spotted before it has spread too far, there are actions that can be tried to possibly control it. We will be discussing this issue and our annual meeting. It is vitally important, so please do your best to attend!

We are asking once again that all Lakefront Property Owners help pay for the cost of registering and maintaining the dam by paying their Maintenance Dues. In addition to the registration, we must pay for the cost of repairs and for the water tests at the Department of Environmental Services. Products That Pollute

The question was raised at the Annual Meeting about which products can increase the phosphorus level in the lake. Our Treasurer, Daphne Lessard is currently researching this subject, but when I was at the Walmart recently, I checked out some of the dishwasher detergents. What I found surprised me. I have been using one of the worst products in terms of phosphorus. Look at these figures and decide for yourself, but I am going to change to Palmolive Gel.

<u>Product</u>	<u>% of Phosphorus</u>
Cascade Complete—powder	7.74
Cascade Complete—gel	6.5
Cascade—powder	7.4
Cascade—gel	4.5
Electrosol—powder	6.1
Electrosol—gel	4.5
Sunlight—powder	4.5
Sunlight—gel	4.3
Palmolive—gel	1.6

Next month we will give a more complete report on products that are safest for the lake.

Steele Road Problem

At the Annual Meeting, concern was expressed about the project on Steele Road to control the flooding. A year ago last winter, Steele Road was so flooded that the town of Bradford put in a 15" pipe under the road and raised the road by a considerable amount. This moved more of the flooding into the Vitale yard and his 4" pipe did not control it. I attended a meeting at the property on the Monday morning after our annual meeting. Peter Fenton, Selectman from Bradford; Tony Vitale, owner of the property; Kenny Lyman, KDL Construction; and Earl Chase, Wetlands Bureau, attended this meeting. Mr. Vitale had been told last year that he didn't need a permit to put in the pipe to pump water from his flooded yard into the lake as long as he didn't penetrate the banking with the pipe. He wants to install a 15" pipe, the same size as the town put in under the road. Mr. Chase told him he did have to have a permit, and he cannot continue with the project until he does. Also, he cannot pump the wetland dry, and there are several other requirements involved in getting the permit. Mr. Vitale can, however, try to unplug the existing 4" pipe as a temporary measure until he gets the permit, which can take up to three months. Please be assured that Mr. Vitale will work with the Wetlands Bureau to try to complete this project within their guidelines.

If you see anyone you think is violating the wetlands laws, you may call the Wetlands Bureau at the Department of Environmental Services at 603-271-1969.
