## Dam Improvement Project

The flood of October '05 threw quite a scare into us, that is, the Dam Committee. Water was starting to go around the dam and it was not even a "hundred year flood." We subsequently learned that State regulations require the District to keep the dam in a condition such that it can survive the hundred-year-flood without damage. After procuring plans and permits to meet that requirement, the construction was completed last November and December. The Dam Bureau has approved the work and says that the dam is in good shape for many years to come.

Since the dam improvements themselves are not very exciting, it might be interesting to find out what was going on behind the scenes leading up to the final event. In 2007 an engineer was hired to draw up plans to increase the height of the east wall to match the west wall and design a berm to prevent water from going around the dam. Then in early 2008 we submitted an application to the Dam Bureau for a permit to construct the improvements. As the engineering work dragged on, we were, at first, hopeful that we could do the improvements in the fall of 2009. When that was not possible, we hoped it would 2010. It was not until 2011 that the plans were ready.

Meanwhile, in early 2009, we started negotiations with the abutting land owners for permission to build the improvements on the their land. A memorandum of understanding (MOU) was agreed to by the east side abutter in June 2009 and an MOU was agreed to the by the west side abutter in September. Also in September, a shoreland permit application was completed and sent to the Wetlands Bureau. It was approved in October.

One of the most important aspects of any Lake is its water quality and for many years the Lake Todd Association, now the Village District has tested the lake for various components which ultimately give us a report card on its condition. ### Dam Improvement Project (continued)

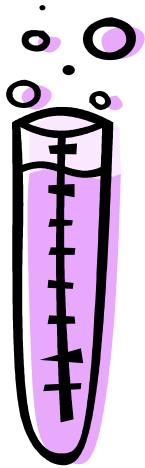

In November 2009, we received a letter from the Dam Bureau reviewing the engineer’s plans, and also informing us that a few rocks has fallen out of the west side downstream wall, and that we would have to have plans and engineering specifications for the repair. Also in that letter was the advice that we secure easements from the abutters for the placement and access to the improvements. Immediately, a letter with an easement document was sent to the abutters with the request that they sign the easement as a supplement to the MOU. The east side easement was in place by the end of December. The west side easement was secured only after twenty one months of difficult and protracted negotiations.

There were not any milestones in 2010 as we continued to prod the engineer to give us some results. By March of 2011, we could see some hope that the job might get done that year. In spite of the fact that the plans had not received final approval and the west side easement was not secured, we put the job out to bid in April. In May we received five bids, two were not qualified and of the remaining three, we selected the lowest bid. Daniels Construction was awarded the contract in June. Also in mid-May we received approval of the construction plans. However a prerequisite for final approval for the permit was approval of a construction inspection plan.

With growing expectation that we would complete the improvements in 2011, we set our sights on beginning on the earliest possible day which was the day after Labor Day. We pressed harder for completion of a construction inspection plan which would meet Dam Bureau approval and for signing of the easement. In late August, some of the easement documents were signed. Then September 6 came and went.

As luck would have it, Hurricane Irene slammed into Vermont at the end of August, washing out roads and bridges. Both our contractor and our engineer were in demand to provide their services to the State of Vermont. Again, progress slowed, although the final easement document was signed by mid-September. Finally, a construction inspection plan was submitted and approved in early October. The dam construction permit was issued on the 21st of October and Daniels started construction on the 31st of October. It was with a great sense of relief that we were able to sit back and watch them do all the work.

All the testers from the Lake are volunteers and trained by VLAP; they run regular sessions yearly and also provide other related items of interest such as the weed watchers program, and in this regard any residents of Lake Todd who want to attend these programs are more than welcome. Our current testers are Bob Doherty, Norm Lehoullier, and yours truly.

You need a boat with a motor as we do traverse a good portion of the Lake, starting at the “deep spot” about a 100’ southeast of the little island. There we drop a Kemmerer bottle to depths of 3 and 6 meters bringing up about a gallon of water which will indicate Conductivity, pH (acidity), Alkalinity, and Turbidity, and total Phosphorus. Samples from these depths are also mixed to get the results for Chlorophyll. We also use a Secchi disk to determine water clarity by noting how deep the disk is before losing sight of it. When the VLAP folks accompany us then they also check dissolved oxygen and temperature at one meter intervals from a depth of six meters to the surface. Lastly they collect Phytoplankton and Cyanobacteria which are a general indicator of lake quality.

VLAP provides comprehensive instruction as to how to collect the sample, the proper bottles to store them in, and a questionnaire as to conditions of the Lake at testing, time of day, date, and who actually did the sampling. We also test Andrew Brook, Reservoir Brook, and the corner of Gillingham Drive where it meets the Weiler driveway as they are the prime feeders of the Lake as well as the outlet at the dam, essentially for the same tests as the “deep spot”. All the equipment specific to the testing is loaned to us by the lab at Colby College in New London, and we return these items as well as the samples promptly following collection as they are subject to deterioration over time. The annual overall cost of the entire program is approximately \$300 and is for the lab fees only.

VLAP provides us with a detailed Biennial Report which is available to any of the littoral owners on the Lake, and provides current as well as historical data. In general our results are consistent with the majority of NH lakes, with our numbers hovering around the median. Without being an expert in the field I think it is apparent that we are fortunate with our sources of water coming mainly from Mount Sunapee, Bald Sunapee, and the surrounding hills so that our water is generally clean while what is in the Lake is being washed out and replenished from these sources. There is year by year data also available on the village district website.

The testing is done three times a year usually during a period from June through October, depending on the schedule of the testers and a member of the NHDES who assists us with the final event. We do the testing in cooperation with the Volunteer Lake Assessment Program (VLAP), a division of the NH Department of Environmental Services, which provides overall guidance and the testing labs.
